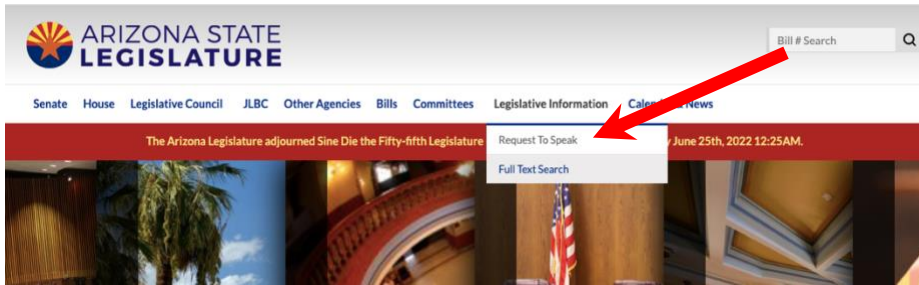
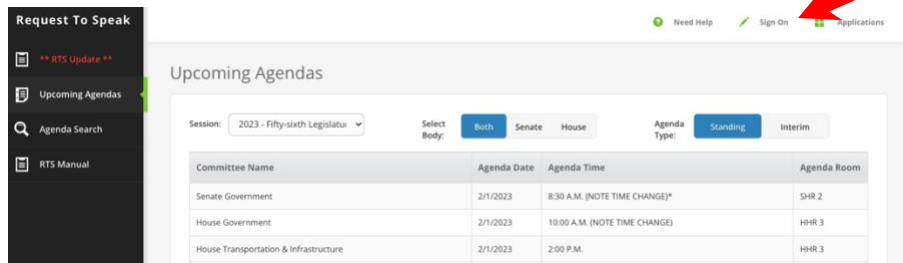


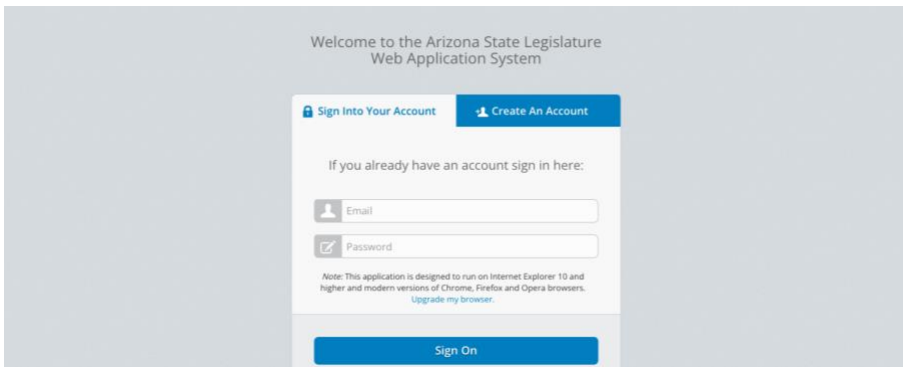
**Step 1:** Go to AZLEG.GOV and click "Request to Speak" under the Legislative Information dropdown menu



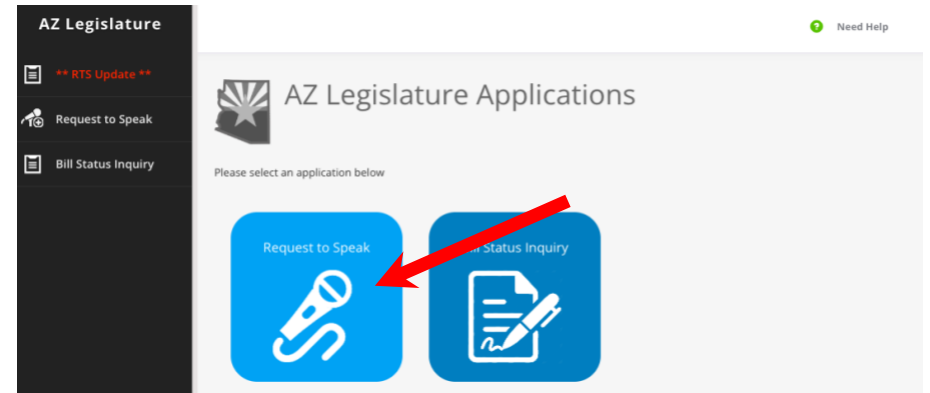
**Step 2:** Click the "Sign On" option at the top right



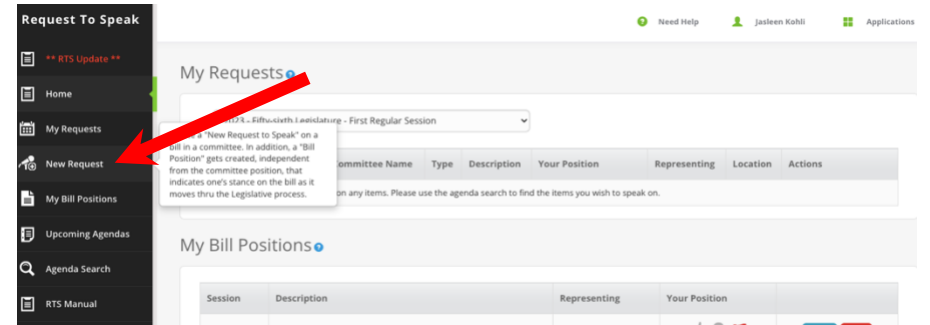
**Step 3:** Sign into your AZLEG account



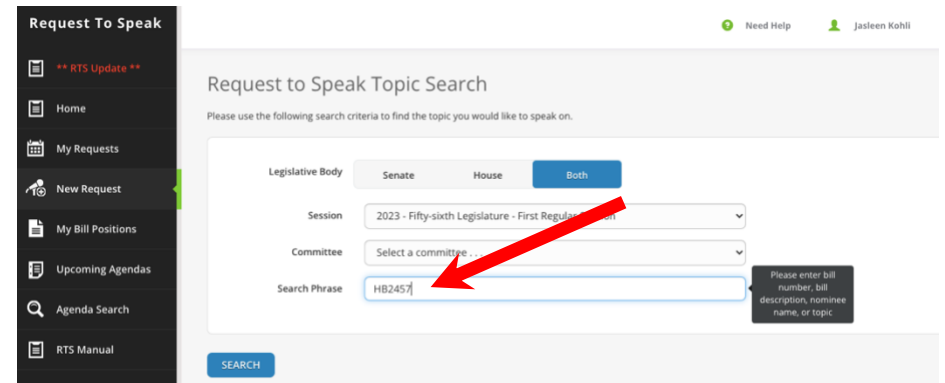
**Step 4:** Click "Request to Speak"
